STANDARDIZED FIELD SOBRIETY TESTING (SFST) INSTRUCTOR REFRESHER (8 HOURS)

COURSE DESCRIPTION:

This 8 hour SFST Instructor Refresher Training will improve the overall technique used by SFST Instructors. Instructors will receive the new 2022 NHTSA curriculum package. This course is for law enforcement officers at the Federal, State, county, and local level who have successfully completed the NHTSA/IACP approved DWI Detection and Standardized Field Sobriety Testing Instructor Development Course and are current SFST Instructors. This course satisfies the Illinois Department of Transportation Sustained Traffic Enforcement Program (STEP) Grant requirement of having an SFST refresher every four years from the date of their last completed certified training. Additional focus is placed on Illinois specific DUI laws, case law, and the administrative code.

Participants will also receive a legal update including processing an arrested driver, warning to motorists, toxicology sampling protocols, laboratory reports, and search warrants. The Illinois Statutes and recent court decisions impacting DUI are covered.

Every officer in the course will receive access to the latest digital resources on the Dynamic Impairment LLC website including flow charts, sample reports for a variety of situations, cheat sheets, research studies, case law and more.

Course is taught by DRE Instructors under the control and approval of the Illinois DRE/SFST Program State Coordinator.
