# EVIDENCE AND PROPERTY MANAGEMENT

## **Course Description:**

This course would be applicable for both civilian and sworn personnel with custodial duties and those responsible for the management of these functions including supervisors and executives. Agency size impacts involved storage variables. Presented materials can identify employable options to preserve evidence integrity from unwarranted court-room challenges. These often out of sign/out of mind minutia level detail if neglected, have insidious damage potentials. Criminal prosecution efforts combined with an agency's public reputation and simultaneously the careers of its Chief/Sheriff downwards to assigned custodians have repeatedly been irreparably damaged for failing to continuously and appropriately manage this assignment.

Systemic evidence storage duties are often assigned with little or no functional training. The involved transactional procures require efforts uncommon to other business type storage facilities. This two-day best practice course is designed for managing a professional evidence storage operation.
