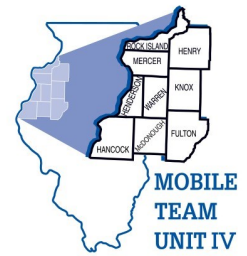

### 8 HOUR ITOA HIGH RISK VEHICLE STOPS

**COURSE DESCRIPTION:** The course is geared towards providing 8 hours of training to sworn Illinois Law Enforcement Officers whose job assignments and activities do not routinely include conducting High Risk Traffic Stops. The course will include a short classroom presentation, where the attendees will review the applicable state and federal laws governing Law Enforcement actions during traffic stops; developing probable cause to conduct a traffic stop; when it is appropriate to employ high risk traffic stop tactics and techniques; an introduction to the nationally recognized best practices to be utilized when conducting a High-Risk Traffic Stop.

The majority of the class will require attendees to participate in Realistic Scenario Based Training sessions, where they will learn, practice and conduct High Risk Traffic Stop training sessions. The course will culminate in the attendees participating in a number of High-Risk Traffic Stop Scenarios that include live role players, converted marking round capable weapons and realistic situations that will require them to show proficiency in performing High Risk Traffic Stops

#### **Per Board approval, this Class Meets the following Mandatory Training Key Guidelines.**

Constitutional/Proper Use of LE. Authority (.5 hours)

Law concerning stops, searches, and use of force (.5 hours; with .5 hours being scenario-based)  
Officer Safety Techniques (.50 hours; with .5 hours being scenario-based)  
De-escalation Techniques (.5 hours)
